

A new policy context

- Policy priorities of the Commission, 6 headline ambitions:
 - Including "An economy that works for people", "A Europe fit for the digital age", "Protecting European way of life", "A stronger Europe in the world"
 - Role of innovative technologies / Importance of ensuring protection of citizens
- Security priorities of the Commission:
 - Strategic priority A strong European Security Ecosystem
 - EU research innovation and technological development for security as key enabler
- Industrial strategy for Europe:
 - Boost investment and competitiveness of EU industry (including SMEs)
 - Security policies to adapt this framework to the specificities of the sector



Why SMEs and Start-ups?

- The EU must master the technologies that are crucial for its security
- Need for a specialised, strong and competitive EU security industry
- 25 million of SMEs (99% of all European firms) are the backbone of our economy
- Innovative SMEs and high-tech Start-ups can transform EU security capabilities
- We need to create a favourable environment to help SMEs bring innovation to the EU security market



Horizon Europe Structure



Horizon Europe Budget




Political agreement December 2020 *€ billion in current prices*









Benefits of participating in EU security R&I

Market uptake of SME innovation

- The habits of successful SMEs when engaging in EU-funded R&I:
 - Know your product, its market and potential customers base before engaging in research and build your strategy basing on that.
 - Have a clear vision of the percentage of work that remains from the current state of development until the product can be positioned in the market. The choices of participation in R&I projects and of using different instruments (e.g. HE Pillar 2 or Pillar 3) will vary depending on what is left to be done.
 - Keep a strong product-focus during project with the clear idea of a market afterwards.
 - Exploit the non-tech aspects of the projects and use them to enter into the market ecosystem.

- Opportunities & resources for security SMEs to develop innovative solutions, scale-up their production, create a business and approach customers.
 - <u>Cluster 3 of Pillar II</u> and the <u>EIC of Pillar III</u> are <u>complementary</u> and not mutually exclusive.
